announces that under Section 20/A of Act XXXVIII of 1992 on the Legal Status of Civil Servants, it is accepting applications for the following positions:

The duration of the civil servant legal relationship:

civil servant relationship with a fixed term from 1 August 2020 - until 31 July 2021

Type of employment:

Full-time employment

Place of work:

Budapest, 1087, II. János Pál pápa tér 30.

The most important tasks of the position and inherent in the management position:

Orchestra musicians have to perform their work to the best of their ability, in line with the artistic position undertaken in their appointment and the instructions of the respective conductor. They are obligated to maintain their instrumental skills at a level that allows them to fully meet even the most stringent of artistic requirements. They have to know their parts when appearing for rehearsals or at least have to have a technical knowledge of their parts when learning new pieces.

Salary and benefits:

The provisions of Act XXXVIII of 1992 on the Legal Status of Civil Servants applies to determining salaries and benefits.

Conditions for application:

- A secondary school education followed by vocational qualification obtained in vocational training, a secondary music school vocational education, or a specialised education obtained in a conservatory,
- foreign citizens awarded the position must obtain a single residence permit/registration certificate before being appointed
- persons with foreign diplomas awarded the position must launch a procedure at the Magyar Ekvivalencia és Információs Központ [Hungarian Center for Equivalence and Information] for the recognition of their education and vocational training before being appointed
- clean criminal record

Documents and certificates to be submitted with the application:

professional curriculum vitae, the applicant's statement on his/her education, the applicant's statement on a clean criminal record, and a data processing statement in which the applicant consents to the processing of his/her personal data in connection with the application

Applicants can start work:

Applicants can fill their positions immediately upon the evaluation of applications.

The method and order for evaluating applications:

Applicants who meet the application requirements will participate in an audition starting at 10 pm on 04 December 2019 (location: the Hungarian State Opera's rehearsal room in Jókai utca - 1066 Budapest, Jókai u. 2-4.). The order of the applications will be randomly selected on 04 December 2019. The audition will consist of two or possibly three rounds. Round 1 will be blind, and round 2 (and possibly 3) will be an open audition. Applicants successfully passing an audition will move on to the next round.

The score for the orchestral passages can be downloaded from the www.opera.hu website. Piano accompaniment will be provided. No reimbursement for travel and accommodation costs will be provided for audition participants. The probationary period will last 4 months. The position involves trips within Hungary and abroad.
